NOTICE AND CERTIFICATE OF LOCATION
OF LODE MINING CLAIM, NEVADA

KNOWN ALIEN BY THESE PRESENTS, that PLACER DOME US INC., having an address of HC 66 BX 1250, CRESCENT VALLEY, NEVADA, 89821 has located the WFM 45 lode mng claim, in Eureka County, in the State of Nevada, on the 21st day of November, 2002.

The claim is located in:

SE Section 12, Township 26 N., Range 48 E., M.D.M.
SW Section 12, Township 26 N., Range 48 E., M.D.M.

The claim is 100 feet long and 300 feet wide and 10 feet is claimed in a East section along the length of the claim and 1490 feet is claimed in a West section along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 150 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a East and West direction. The description of the claim is as follows:

Begin at Corner No. 1, the Northeast Corner of the claim;
Thence South, 300 feet to Corner No. 2, the Southeast Corner;
Thence West, 1500 feet to Corner No. 3, the Southwest Corner;
Thence North, 300 feet to Corner No. 4, the Northwest Corner;
Thence East, 1500 feet to Corner No. 1, the Northeast Corner;
the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

As erected on ground, each boundary or corner is marked as described above by an aluminum tag attached to the monument.

The monument and markings of the above mentioned corners on the ground was completed by the 21st day of November, 2002, and the location work consisted of making a claim map as provided in NRS 517.040. Two copies of this map have been filed with the Eureka County Recorder and the lode claim filing fee has been paid to the County Recorder.
