NOTICE AND CERTIFICATE OF LOCATION

The claim is 150 feet long and 100 feet wide and 1350 feet is claimed in a North _____ cction along the length of the claim and 150 feet is claimed in a South _____ cction along the length of the claim from the Location Monument at which a Notice of Loccon is posted, together with 50 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and South direction. The description of the claim is as follows:

Beginn: at Corner No. 1, the Northeast Corner of the claim;
Thence South _____, 1500 feet to Corner No. 2, the Southeast Corner;
Thence West _____, 100 feet to Corner No. 3, the Southwest Corner;
Thence North _____, 1500 feet to Corner No. 4, the Northwest Corner;
Thence East _____, 100 feet to Corner No. 1, the Northeast Corner;
the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location & markings on each boundary or corner monument is as follows:

As erected on ground, each boundary or corner is marked as described above by an aluminum tag attached the monument.

The monument and markings of the above mentioned corners on the ground was completed by the 21st day of November, 2002, and the location work consisted of making a claim map as provided NRS 517.040. Two copies of this map have been filed with the Eureka County Record and the lode claim filing fee has been paid to the County Recorder.
