NOTICE AND CERTIFICATE OF LOCATION
OF LODE MINING CLAIM, NEVADA

KNOWN ALIEN BY THESE PRESENTS, that PLACER DOME US INC., having an address of HC 66 IX 1250, CRESCENT VALLEY, NEVADA, 89821 has located the WFM 55 lode mag claim, in Eureka County, in the State of Nevada, on the 18th day of DECEMBER 2002.

The claim is located in:

NW Section 6, Township 25 N., Range 49 E., M.D.M.
NE Section 6, Township 25 N., Range 49 E., M.D.M.
Section , Township N., Range E., M.D.M.
Section , Township N., Range E., M.D.M.

The claim is 100 feet long and 50 feet wide and 10 feet is claimed in a N 89° 30' 07" E section along the length of the claim and 1490 feet is claimed in a S 89° 30' 07" W section along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 25 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a N 89° 30' 07" E and S 89° 30' 07" W direction. The description of the claim is as follows:

Begin at Corner No. 1, the Northeast Corner of the claim;
Thence 0° 29' 53" E, 50 feet to Corner No. 2, the Southeast Corner;
Thence 89° 30' 07" W, 1500 feet to Corner No. 3, the Southwest Corner;
Thence 0° 29' 53" W, 50 feet to Corner No. 4, the Northwest Corner;
Thence 89° 30' 07" E, 1500 feet to Corner No. 1, the Northeast Corner;
the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

No. 4: <u>Corner No.</u>	<u>NW Cor. WFM 55</u>	<u>1 1/2" x 1 1/2" Wood Post, 4' Long</u>

As erected on ground, each boundary or corner is marked as described above by an aluminum tag attached to the monument.

The monument and markings of the above mentioned corners on the ground was completed by the 18 day of DECEMBER 2002, and the location work consisted of making a claim map as provided in NRS 517.040. Two copies of this map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
