That on or about November 22, 2002, the said JAMES D. McDERMOTT paid the sum of \$20,096.12, and on or

about December 2, 2002, paid the additional sum of \$16,561.35 leaving a balance due and owing in the sum of \$32,053 for the payment of which demand was made on the said JAMES D. McDERMOTT on about January 14, 2003, no part of which has been paid and there is now due, owing and unpaid from the said JAMES D. McDERMOTT for the materials and labor furnished and supplied by M & S TRUCKING & CONSTRUCTION the sum of \$32,056.63, no part of which has been paid.

That more than ninety (90) days have expired since the delivery of materials and the performance of labor by the lien claimant and that there remains due and owing and unpaid the sum of \$32,056.63 after deducting all of just credits and offsets.

WHEREFORE, MARK A. LORENZO, President of M & S TRUCKING & CONSTRUCTION, claims the benefit of the law relative to liens upon real property including NRS Sections 108.21 seq., and all acts are mandatory thereof or supplementary thereto.
