Nabors Drill Rig #476


The claim is made pursuant to Chapter 108 of the Nevada Revised Statutes for the furnishing of labor or materials upon the Property.

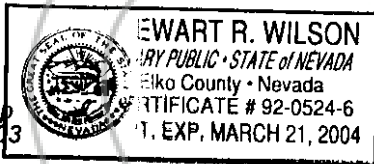
