NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN that Summit Engineering Corporation, a Nevada corporation ("Summit") claims a Mechanic's Lien in the amount of Three thousand Three hundred Forty dollars & 00/100 (\$ 3,340.00) upon that certain real property located in the County of Eureka, State Nevada, Eureka O.A. Site, BLM Lease Number N66394. This claim is made pursuant to laws of the State of Nevada, particularly Chapter 108 of the Nevada Revised Statutes, as amended, for the value of engineering related services and/or labor ("Engineering Services" furnished by Summit as an engineer, land surveyor or geologist in relation to real property for a building or other structure.

Claimant further states:

1. The name of the owner or reputed owner of the Property is:

2. The name of the person by whom Summit was employed and to whom Summit furnished Engineering Services is:
Contemporary Constructors Inc. P.O. Box 790848 San Antonio, Texas 78279-0848.
3. The terms, time and conditions of the contract was that Summit would furnish Engineering Services on a Lump Sum basis per contract. Payment for the Engineering Services is to be made within thirty (30) days from the date of the invoice. Any delinquent payment beyond the 30 days is subject to 1.5 percent interest per month, 18% APR.
4. Ninety (90) days from completion of the work of improvement, last delivery of materials or last performance of labor have not elapsed prior to the date of this Notice of Lien. Summit commenced furnishing the Engineering Services on or about 9/07/2002, and the last Engineering Services furnished by Summit was on or about 11/22/2002. NO Notice of Completion has been filed.
5. The amount due and owing to Summit after deducting all just credits and offsets is Three thousand Three hundred Forty dollars and 00/100 (\$3,340.00) and is now due and owing to Summit for Engineering Services. Summit claims a lien upon the Property for this amount plus interest at 18% APR, costs and attorney's fees as provided for by contract and law.
6. The description of the Property to be charged is the Eureka O.A. Site, BLM Lease No. N66394.

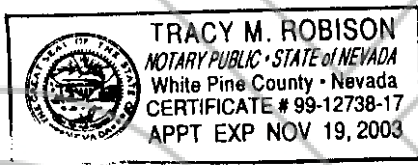
