

5 2001, until the judgment is satisfied in full.

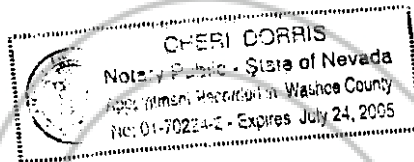
