NOTICE AND CERTIFICATE OF LOCATION  
OF LODE MINING CLAIM, NEVADA

KNOWN ALL MEN BY THESE PRESENTS, that PLACER DOME U.S. INC., having an address of HC 66 BOX 1250, CRESCENT VALLEY, NEVADA, 89821, has located the WFM 50 lode minicclaim, in Eureka County, in the State of Nevada, on the 1<sup>st</sup> day of April, 2003.

The claim is located in :

SE 1/4 Section 14, Township 26N., Range 48E., M.D.M.  
SW 1/4 Section 13, Township 26N., Range 48E., M.D.M.  
     1/4 Section     , Township     N., Range     E., M.D.M.  
     1/4 Section     , Township     N., Range     E., M.D.M.

The claim is 100 feet long and 600 feet wide and 50 feet is claimed in a East direction along the length of the claim and 950 feet is claimed in a West direction along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a East and West direction. The description of the claim is as follows:

Beginning Corner No. 1, the Northeast Corner of the claim;  
Thence South, 600 feet to Corner No. 2, the Southeast Corner;  
Thence West, 1000 feet to Corner No. 3, the Southwest Corner;  
Thence North, 600 feet to Corner No. 4, the Northwest Corner;  
Thence East, 1000 feet to Corner No. 1, the Northeast Corner;  
the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

No. 3: <u>Corner No. 3</u>	<u>SW Cor. WFM 50</u>	<u>1½" x 1½" Wood Post, 4' Long</u>
No. 4: <u>Corner No. 4</u>	<u>NW Cor. WFM 50</u>	<u>1½" x 1½" Wood Post, 4' Long</u>

As erected on the ground, each boundary or corner is marked as described above by an aluminum tag attached to the monument.

The monumentation and markings of the above mentioned corners on the ground was completed by the 1<sup>st</sup> day of April, 2003, and the location work consisted of making a claim map as provided NRS 517.040. Two copies of this map have been filed with the Eureka County Recorder, and lode claim filing fee has been paid to the County Recorder.
