## LEASE BY EUREKA COUNTY FROM SCHOOLISTRICT OF BEOWAWE ELEMENTARY SCHOOL

This lease entered into this 6th day of June, 2003, by and between Eure County, a political subdivision of the State of Nevada, by and through its Board of Eureka County Commissioners (Eeka County), and the Board of Trustees of the Eureka County Sool District, a political subdivision of the State of Nevada Shool).

School hery leases to Eureka County the premises described as a ortion of the Beowawe Elementary School in Beowawe, Nevada, including the Gymnasium building and restrooms, the hallway beten the Gymnasium and main building, and the playground adjact to the Gymnasium, on the following terms and conditions:

- 1. Term of Lee: This lease shall be for one (1) year, starting July  $1,\,\,03$ , and ending June 30, 2004.
- 2. Rent: Eure County agrees to pay One Dollar (\$1.00) per year in rent.
- 3. <u>Use of Premes</u>: Eureka County agrees to use the premises for <u>Juvenile Pration</u> programs, and not permit any waste or abuse of the premes.
- 4. <u>Maintenance ad Repairs</u>: Eureka County agrees to maintain the premises, rsonable wear and tear excepted; except the School shall b responsible for maintaining the roof and structural componts of the premises.
- 5. Alterations and Improvements: No alterations are allowed without the permaion of the School.
- 6. <u>Insurance a Indemnification</u>: During the lease term Eureka County shall matain public liability and property damage insurance with ibility limits of not less than \$500,000 per person, \$1,000,0 per occurrence, and property damage limits of not less than \$1,000 per occurrence, with the School listed as a coinsured. Eeka County shall also maintain fire insurance with vandalism a malicious mischief endorsements to cover 100% of the replaceme value of the premises.

Eureka County were all claims against the School, for damages arising out of t use of the premises.

7. <u>Utilities</u>: ureka County agrees to pay all utilities connected with t premises during the lease term.
