
KNOW ALL MENY THESE PRESENTS:

O. 1 3358, Englewood, CO 80155 (hereinafter referred to as "Assignee"), all of Assignor's right, title and intst in and to the oil, gas, casinghead gas, and other hydrocarbon substances, produced, saved and marke from the following described land pursuant to those certain oil and gas leases in Eureka County, Neva, described on Exhibit "A" attached hereto and made a part hereof.

TO HAVE AND TO HO the interest herein transferred and assigned unto Assignee, its successors and assigns, forever, subjectly to the following terms and provisions: That

- A. The overrid royalty interest herein transferred is payable out of and only out of the oil and gas proeed, saved and marketed, pursuant to the terms and provisions of the above described ond gas leases.
- B. This assignnt of overriding royalty is made without warranty of any kind, either express or implied.
- C. It is the int of Assignor to convey to Assignee all its overriding royalty acquired by virtue of th certain conveyances recorded in Book 272 at Page 144, and in Book 272 at Page 147 or Eureka County, Nevada records.
- D. It is the futr intent of Assignor to convey to Assignee all other mineral and royalty interests thae may own in the Three Bar Unit Area previously vested in H. K. Veal & Co., and in State of Nevada generally, whether such interests are described herein or not.
