The claim is 715.70 feet long and 600 feet wide and 10 feet is claimed in a
S0°36'32"E direction along length of the claim and 705.70 feet is claimed in a N0°36'32"W direction along
the length of the claim from Location Monument at which a Notice of Location is posted, together with 300
feet in width on each side of center of the claim. The general course of the lode deposit, as can be determined
at this time is in a S0°36'32"E and N0°36'32"W direction. The description of the claim is as follows:

Beginning at Corner 1, the Northeast Corner of the claim;
Thence S0°36'32"E 711.73 feet to Corner No. 2, the Southeast Corner;
Thence S89°23'28"W 600 feet to Corner No. 3, the Southwest Corner;
Thence N0°36'32"W 715.70 feet to Corner No. 4, the Northwest Corner;
Thence N89°46'11"W 600.01 feet to Corner No. 1, the Northeast Corner;
the place of beginning.
