further appearing that the named Defendants have been duly and

appear, answer, move or file any pleading has expired, AND GOOD

1 CAUSE APPEARING THEREFOR,

2 ITS HEREBY ORDERED that the Default of the Defendants,  
3 NICKLOMA HAWCHI and JOSEPH NASARIO, be and the same is hereby  
4 entered by the Court.

5 ITS FURTHER APPEARING TO THE COURT:

6 1. That Plaintiff is entitled to Default Judgment  
7 against the defendants, NICKLOMA HAWETCHI and JOSEPH NASARIO, and  
8 that Defendants are indebted to the Plaintiff in the sum of  
9 \$1,098.53 for drilling services, for which Defendants have failed  
10 and refused to pay.

11 2. That Plaintiff is entitled to a reasonable attorney  
12 fee in the sum of \$479.48, together with court costs to be incurred  
13 by Plaintiff in connection herewith.

14 3. That Plaintiff is entitled to interest on the sum of  
15 \$1,098.53 at the rate of eighteen percent (18%) per annum from  
16 October 4, 2002, until paid.

17 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND  
18 DECREED that the Plaintiff have judgment against the Defendants,  
19 NICKLOMA HAWCHI and JOSEPH NASARIO, as follows:

20 1. Principal sum of \$1,098.53.

21 2. For interest on the principal sum of \$1,098.53 at  
22 the statutory rate of eighteen percent (18%) per annum from the  
23 date of October 4, 2002, until paid.

24 3. The sum of \$479.48 as and for reasonable attorney  
25 fees.

26 4. Court costs to be incurred, together with all other  
27 legal costs to be incurred by Plaintiff in connection herewith.
