The Claim is approximately 1500 feet long and 600 feet wide, such that 1470 feet are claimed in a East direction and 30 feet in a Westerly direction from the point of discovery (nucleus of location), at which the Notice of Location was posted, together with 300 feet on each side of monument of location and center line of the Claim. The general course of the lode or vein is from the East the West direction.
