**RECORDER'S STAMP**

The Claim is approximately 500 feet long and 600 feet wide, such that 1450 feet are  
claimed in a SOUTHERLY direction and 50 feet in a NORTHERLY direction from the point of discovery  
(monument of location), at which the Notice of Location was posted, together with 300 feet on each side of
