RECORDER'S STAMP

The Claim is approximately 500 feet long and 600 feet wide, such that 1450 feet are
claimed in a SOUTHEASTLY direction and 50 feet in a NORTHEASTLY direction from the point of discovery
(monument of location), at which the Notice of Location was posted, together with 300 feet on each side of
the monument of location on either line of the Claim. The general course of the lode or vein is from the
NORTH to the SOUTH direction.
