### CERTIFICATE OF LOCATION

The undersigned certifies as follows:

1. The name and mailing address of the locator is Lander Resources LLC, 1 East Liberty Street, Suite 424, Reno, NV 89501.

2. That on the 14<sup>th</sup> of October, 2003, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the locator located and claimed the lode mining claim called the **Flynn 90** mining claim (the claim).

3. The claim is located in the following quarter sections:

SW $\frac{1}{4}$  of Section 10 Township 26 North, Range 52 East

$\frac{1}{4}$  of Section Township North, Range East

$\frac{1}{4}$  of Section Township North, Range East

NW $\frac{1}{4}$  of Section 10 Township 26 North, Range 52 East

M.D.B. & M., Eureka County, Nevada

4. The locator claims 1475 feet in a South direction and 25 feet in a North direction from the monument of location at which the Notice of location is posted, together with 300 feet in width on each side of the center of the vein or lode. The general course of the lode or vein, as near as may be determined, is North and South.

5. The position of each corner of the Claim is shown on the mining claim map recorded with this Certificate. The number, position and markings on each corner monument are as follows:

6. As erected on the ground, each corner monument consists of a wood post at least 1½ inches in diameter by four feet in length, set one foot in the ground and marked as described above by metal tags.

The location work consisted of making and recording of duplicate claim maps as prescribed in NRS 517.040 and incorporated by reference in this Certificate.
