the context demands).


WITNESSETH that: Grantor, for and in consideration of Ten Dollars (\$10.00) and other good and valuable considerations

situate, lying and being in Eureka Co., Nevada and more particularly describes as follows:





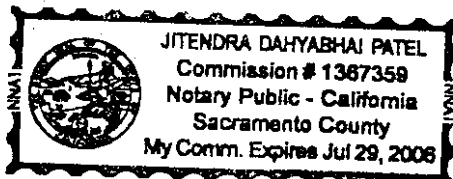
