SHERIFF'S DEED

This indenture, made this 18th day of December, 2003, between LARRY ETTER, Sheriff of Eureka County, Nevada, and W.E. Vining, as trustee for W.E. Vining Company, Inc., of 930 Vista Lago Way, Boulder City, Clark County, Nevada.

By virtue of a writ of execution dated August 15, 1991, directed and delivered to Ken Jones, Sheriff of Eureka County and issued by the Seventh Judicial District Court of the State of Nevada, in and for the County of Eureka, on a judgment rendered on May 21, 1991, in an action entitled W.E. Vining Company, Inc. v. Norse Windfall Mines, Inc., Eureka Ventures, Norse Minerals, Inc., Viking Minerals, Inc., and Vest U.S.A., Case #3222 in said Court, in favor of W.E. Vining Company, Inc., plaintiff, and against Norse Windfall Mines, Inc., Eureka Ventures, Norse Minerals, Inc., Viking Minerals Inc., and Vest U.S.A., defendants, for the sum of \$1,306,198.50, Ken Jones, as Sheriff of Eureka County, was commanded to satisfy this judgment with interest and costs out of the personal property of defendants, and if sufficient personal property could not be found, then out of the real property belonging to defendants in Eureka County.

Vining Company, Inc., its successors and assigns, all the estate, right, title, and interest of defendants which defendants had on February 10, 1993, or at any time afterwards, of, in, and to all the following real property situated in the County of Eureka, State of Nevada:
