4. The Judgment has been partially satisfied in the amount of \$821.87.


5. Post-Judgment interest has accrued at the legal interest rate, and the unpaid judgment balance is \$18,404.56.

7. The exact amount due on the Judgment as of December 12, 2003, is \$18,404.56.


