The Claim is approximately 1500 feet long and 350 feet wide, such that 20 feet are claimed in a south direction and 1480 feet in a north direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 175 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the North to the South direction.

To tie this claim to a Public Survey, the NE Corner (Cor. No.1), of this claim lies approximately 3440 feet south and 9134 feet west from the SW Corner of Section 6, T. 18 N, R. 54 E, M.D.B.M.
