The Claim is approximately 1500 feet long and 600 feet wide, such that 340 feet are  
claimed in a South direction and 1160 feet in a North direction from the point of discovery  
(monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the  
monument of location and center line of the Claim. The general course of the lode or vein is from the North to the  
South direction.

To tie this claim to a Public Survey, the NE Corner (Cor. No. 1), of this claim lies approximately 440 feet  
South and 8884 feet West from the SW Corner of Section 6, T. 18 N, R. 54 E, M.D.B.M.
