7. That Petitioner is informed and believes that, at the time of Decedent's death, there were no liens or encumbrances of record against said parcel of real property. The taxes have been paid through the current tax year, 2003-2004.

8. That the above described real property should be distributed to Decedent's husband, ROBERT H. ANTHONY, as his sole and separate property.

9. That this Petition is made pursuant to NRS 146.070.

10. That Petitioner has engaged MATTHEWS AND WINES, P.C., to petition this Court in both this matter and in a companion action, and will incur court costs and legal fees; this Court should order payment of the costs incurred herein, together with a reasonable fee, payable to Matthews and Wines, P.C.

11. That any and all other items of real or personal property located in the State of Nevada hereinafter discovered with a value less than \$50,000.00 should be set aside pursuant hereto without further order of this Court to ROBERT H. ANTHONY.

NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

That the total value of the Estate does not exceed the sum of \$50,000.00, that the same shall not be administered upon, but shall be assigned and set apart, including hereinafter discovered items of real and personal property with a value less than \$50,000.00, to ROBERT H. ANTHONY as his sole and separate property.
