1 4. That at the time of Decedent's death he left an estate consisting of the following
2 described parcels of real property within the County of Eureka, State of Nevada; that the value of
3 such real property does not exceed the sum of \$50,000.00; that all of said Estate is within the
4 jurisdiction of the above entitled Court and more particularly described as follows:

14 TOGETHER WITH any and all buildings and improvements situate thereon.

15 TOGETHER WITH the tenements, hereditament and appurtenances thereunto
16 belonging or in anywise appertaining, the reversion and reversion, remainder and
17 remainders, rents, issues and profits thereof.

18 SUBJECT TO all reservations, restrictions or covenants of record.

19 6. That the total value of the real property for the purpose of this proceeding is
20 \$15,240.00.

21 7. That Petitioner is informed and believes that, at the time of Decedent's death, there
22 were no liens or encumbrances of record against said parcel of real property. The taxes have been
23 paid through the current tax year, 2003-2004.

24 8. That the 2003-2004 Eureka County, Nevada, ad valorem tax bills establish the
25 appraised value for the three parcels.

26 9. That a copy of Decedent's Pour Over Will, is attached to the Petition, together with
27 a copy of the relevant portions of the ANTHONY LIVING TRUST, dated February 19, 1994. The
28 effect of these documents is that the property described herein is distributable to the heirs outright
and free of the Trust.

 10. That the heirs have allocated the Trust assets among themselves, and have agreed
that the property described herein should be distributed to BARBARA ROWLAND, as her sole and
separate property.

1 11. That based upon that agreement, the above described real property should be
2 distributed to Decedent's daughter, BARBARA ROWLAND, as her sole and separate property.

3 12. That this Petition is made pursuant to NRS 146.070.

4 13. That Petitioner has engaged MATTHEWS AND WINES, P.C., to petition this Court,
5 and will incur court costs and legal fees; this Court should order payment of the costs incurred
6 herein, and in regard to the ESTATE OF MARIE UPCHURCH ANTHONY, together with a
7 reasonable fee in the sum of \$400.00, payable to MATTHEWS AND WINES, P.C.

8 14. That any and all other items of real or personal property located in the State of
9 Nevada hereinafter discovered with a value less than \$75,000.00 should be set aside pursuant hereto
10 without further order of this Court to BARBARA ROWLAND and WAYNE H. ANTHONY, share
11 and share alike.

12 NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

13 1. That the total value of the Estate does not exceed the sum of \$75,000.00, that the real
14 property herein described shall not be administered upon, but shall be assigned and set apart to
15 BARBARA ROWLAND, as her sole and separate property.

16 2. That any and all other items of property, including hereinafter discovered items of
17 real and personal property with a value less than \$75,000.00, be set over to BARBARA
18 ROWLAND and WAYNE H. ANTHONY, share and share alike, without further administration
19 or order of this court.

20 3. That Petitioner shall pay a reasonable attorney fee of \$400.00 to MATTHEWS AND
21 WINES, P.C., together with all costs incurred in this matter, and in the matter of the ESTATE OF
22 MARIE UPCHURCH ANTHONY.
