The Claim is approximately 1500 feet long and 600 feet wide, such that 5 feet is claimed in a  
East direction and 1495 feet in a West direction from the point of discovery (monument of location),  
at which the Notice of Location was posted, together with 300 feet on each side of the monument of  
location and center line of the claim.

The general course of the lode or vein is from East to the West in direction.

The number, location and markings on each corner monument are as follows:

Corner No.1 the Northwest Corner is a 2"x2"x4'ft. wood post.

Corner No.2 the Northeast Corner is a 2"x2"x4'ft. wood post.

Corner No.3 the Southeast Corner is a 2"x2"x4'ft. wood post.

Corner No.4 the Southwest Corner is a 2"x2"x4'ft. wood post.
