THIS CORRECTION QUITCLAIM DEED (this "Deed"), dated this 16th day of February, 2004, to be effective as of March 10, 1995, is from BARRICK GOLDSTRIKE MINES INC., a Colorado corporation, P.O. Box 29, Elko, Nevada 89803 ("Barrick"), to DEAN A. RHOADS and SHARON RHOADS (the "Rhoads"), as Trustee's of the Dean and Sharon Rhoads Trust dated October 21, 1997 ("Trustees").

RECITALS

- A. Barrick and Rhoads entered into that certain Agreement dated February 25, 1995 (the "Agreement"), pursuant to which the parties agreed to exchange certain parcels of real property.
- B. Paragraph 10(a) of the Agreement provided the Rhoads to convey the real property and any improvements located thereon to Barrick and further provided:

"in the conveyance, the Rhoads will reserve all water rights with the right to transfer the same to other property..."

- C. - D. A Correction Quitclaim Deed to correct the inadvertent omission of an express reservation of water rights and to reaffirm the reservation of water rights contained in paragraph 10(a) of the Agreement was executed by Barrick on November 13, 2002, to be effective as of March 10, 1995, and recorded on November 19, 2002 in the real property records of Eureka County, Nevada as Entry No. 179485 in Book 354, page 121, (the "Correction Deed").
- E. The Correction Deed contained a typographical error that incorrectly described the property to be within Township 35 North. The property should have been correctly described as being within Township 36 North. This Deed is executed and delivered to correct the above Correction Deed to properly describe the property to be within Township 36 North.

BARRICK, for and in consideration of the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby remise, release and forever quitclaim unto the Trustees, all right, title and interest in and to the water rights reserved by the Rhoads in paragraph 10(a) of the Agreement, said water rights being appurtenant to or related to the following described property:

Section 22: SW1/4 Section 28: NE1/4
