The claim is approximately 1500 feet long and 600 feet wide, such that 10 feet are claimed in a southerly direction and 1490 feet in a northerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein is from the southerly to the northerly direction.


The number, location and markings on each corner monument are as follows:

No. 2: Southeast Corner	SE Corner <u>LONE 1084</u>	2" X 2" X 4' wood post
No. 3: Southwest Corner	SW Corner <u>LONE 1084</u>	2" X 2" X 4' wood post
No. 4: Northwest Corner	NW Corner <u>LONE 1084</u>	2" X 2" X 4' wood post

As erected on the ground, each corner monument is marked as described above by a scribed metal tag. The work of location consisted of making a claim map as provided in N.R.S. 517.040 which map is recorded herewith.
