The claim is approximately 1500 feet long and 600 feet wide, such that 10 feet are claimed in a easterly direction and 1490 feet in a westerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein is from the easterly to the westerly direction.


The number, location and markings on each corner monument are as follows:

No. 1: Northeast Corner	NE Corner <b>HAY 150</b>	2" X 2" X 4' wood post
No. 2: Southeast Corner	SE Corner <b>HAY 150</b>	2" X 2" X 4' wood post
No. 3: Southwest Corner	SW Corner <b>HAY 150</b>	2" X 2" X 4' wood post
No. 4: Northwest Corner	NW Corner <b>HAY 150</b>	2" X 2" X 4' wood post

As erected on the ground, each corner monument is marked as described above by a scribed metal tag. The work of location consisted of making a claim map as provided in N.R.S. 517.040 which map is recorded herewith.
