The claim is approximately 1500 feet long and 600 feet wide, such that 1490 feet are claimed in a  
easterly direction and 10 feet in a westerly direction from the point of discovery (monument of location),

 location and center line of the claim. The general course of the lode or vein is from the easterly to the  
westerly direction.
