The claim is located in the:

SE 1/4 Section 10, Township 27N., Range 50E., M.D.M.
SW 1/4 Section 11, Township 27N., Range 50E., M.D.M.
NW 1/4 Section 14, Township 27N., Range 50E., M.D.M.
NE 1/4 Section 15, Township 27N., Range 50E., M.D.M.

The claim is 1500 feet long and 600 feet wide and 10 feet is claimed in a North direction along the length of the claim and 1490 feet is claimed in a South direction along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and South direction. The description of the claim is as follows:

Beginning at Corner No. 1, the Northeast Corner of the claim;

Thence South, 1500 feet to Corner No. 2, the Southeast Corner;

Thence West, 600 feet to Corner No. 3, the Southwest Corner;

Thence North, 1500 feet to Corner No. 4, the Northwest Corner;

Thence East, 600 feet to Corner No. 1, the Northeast Corner;
the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

Two copies of this map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
