TO HAVE AND TO HOLD the said premises unto the said Grantees, and to their heirs, executors, successors and assigns thereof.

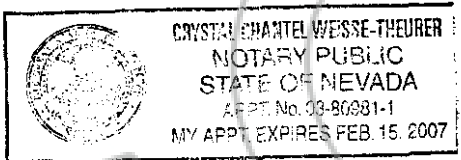
