The Claim is approximately 1500 feet long and 600 feet wide, such that 20 feet are claimed in a West direction and 1480 feet in a East direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the East to the West direction.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument consists of 2"x2"x4' wooden post with aluminum tags attached, scribed with claim name and corner description set on foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the northeast corner:

thence: 600 feet S to the SE corner, corner No. 2,  
thence: 1500 feet W to the SW corner, corner No. 3,  
thence: 600 feet N to the NW corner, corner No. 4,  
thence: 1500 feet E to the NE corner, corner No. 1,
