3. CLAIM MARKINGS.





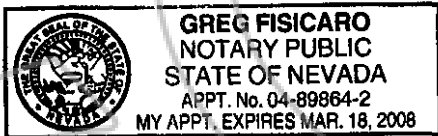
