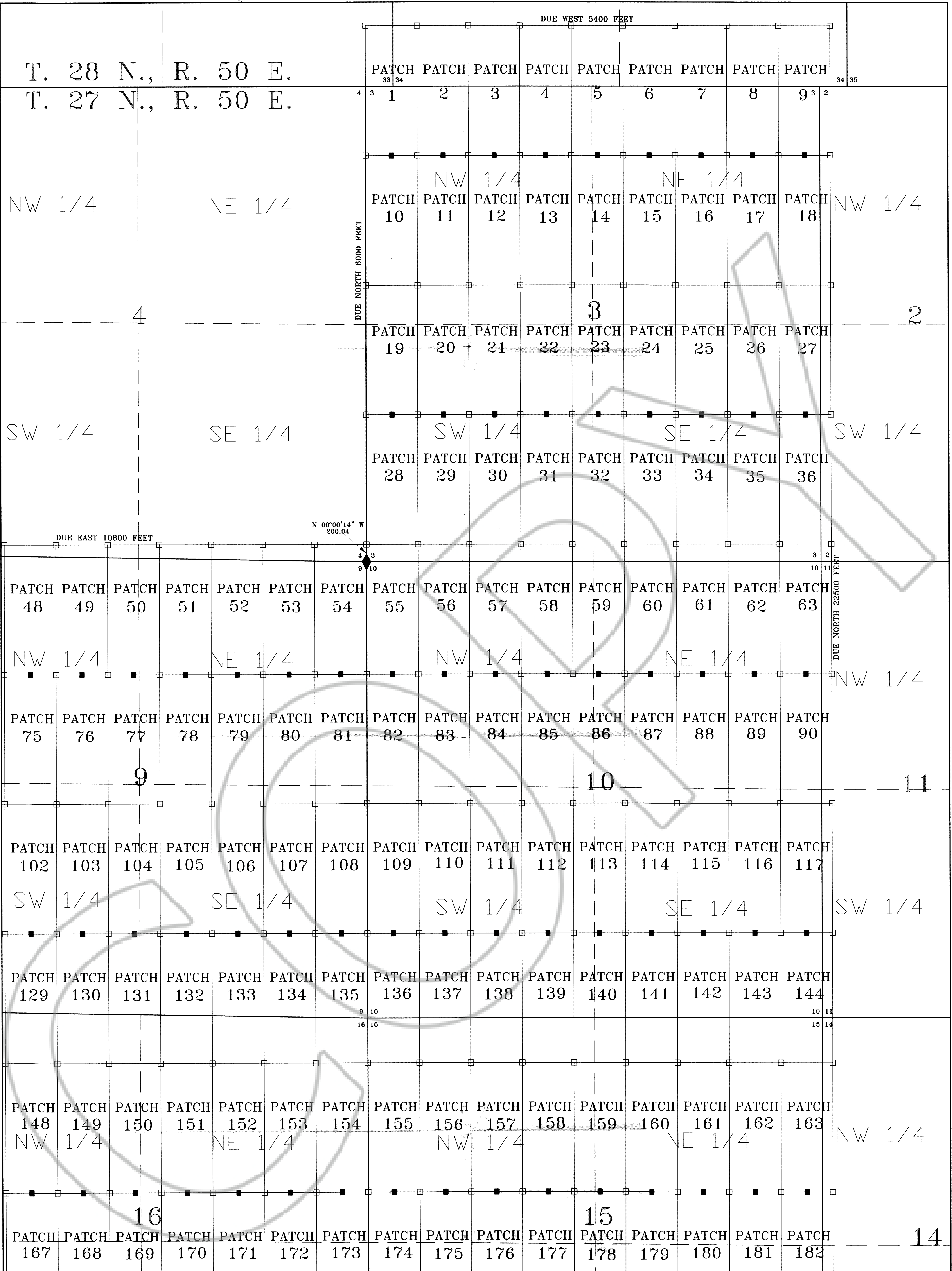




MAP OF THE

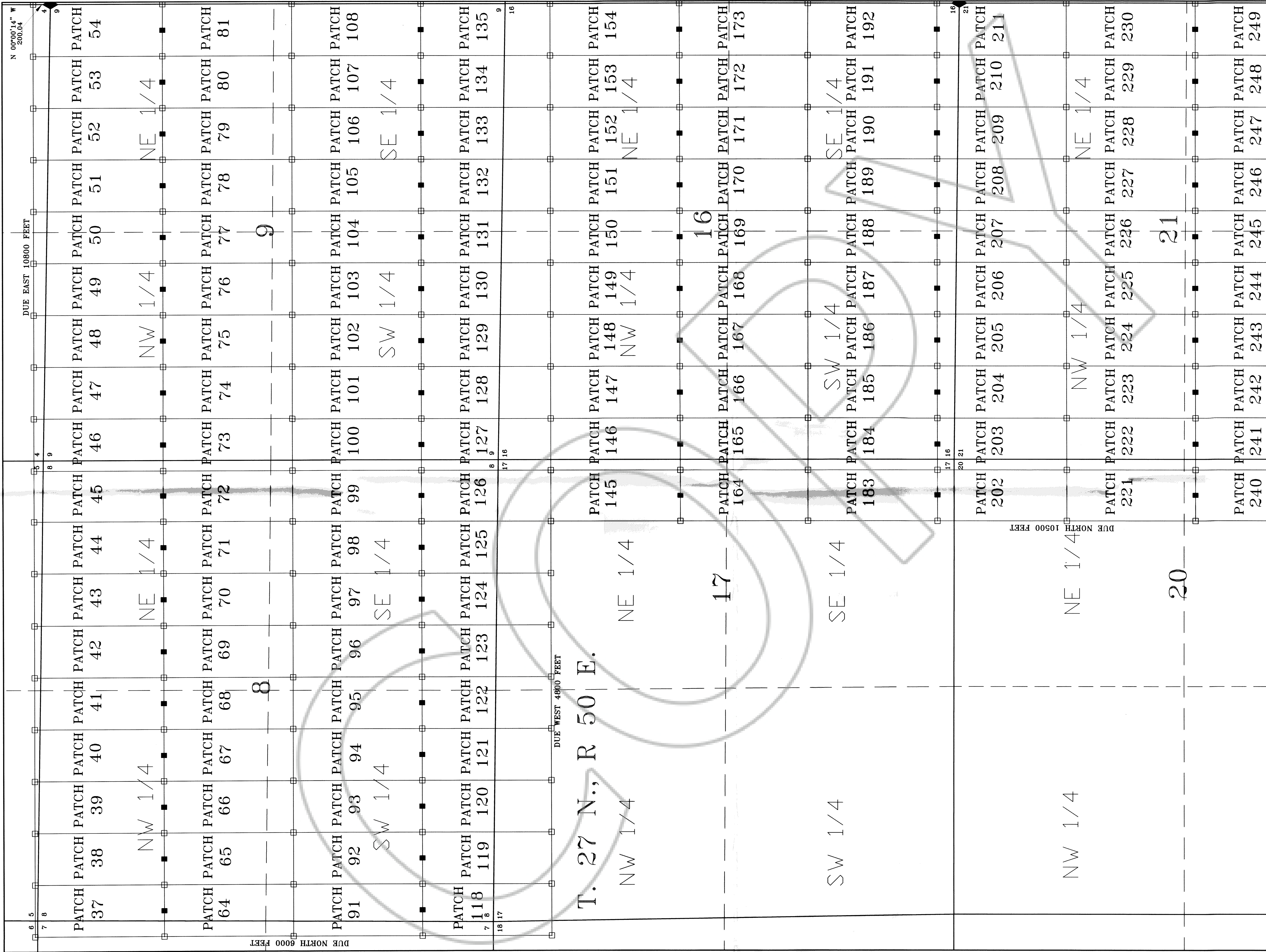

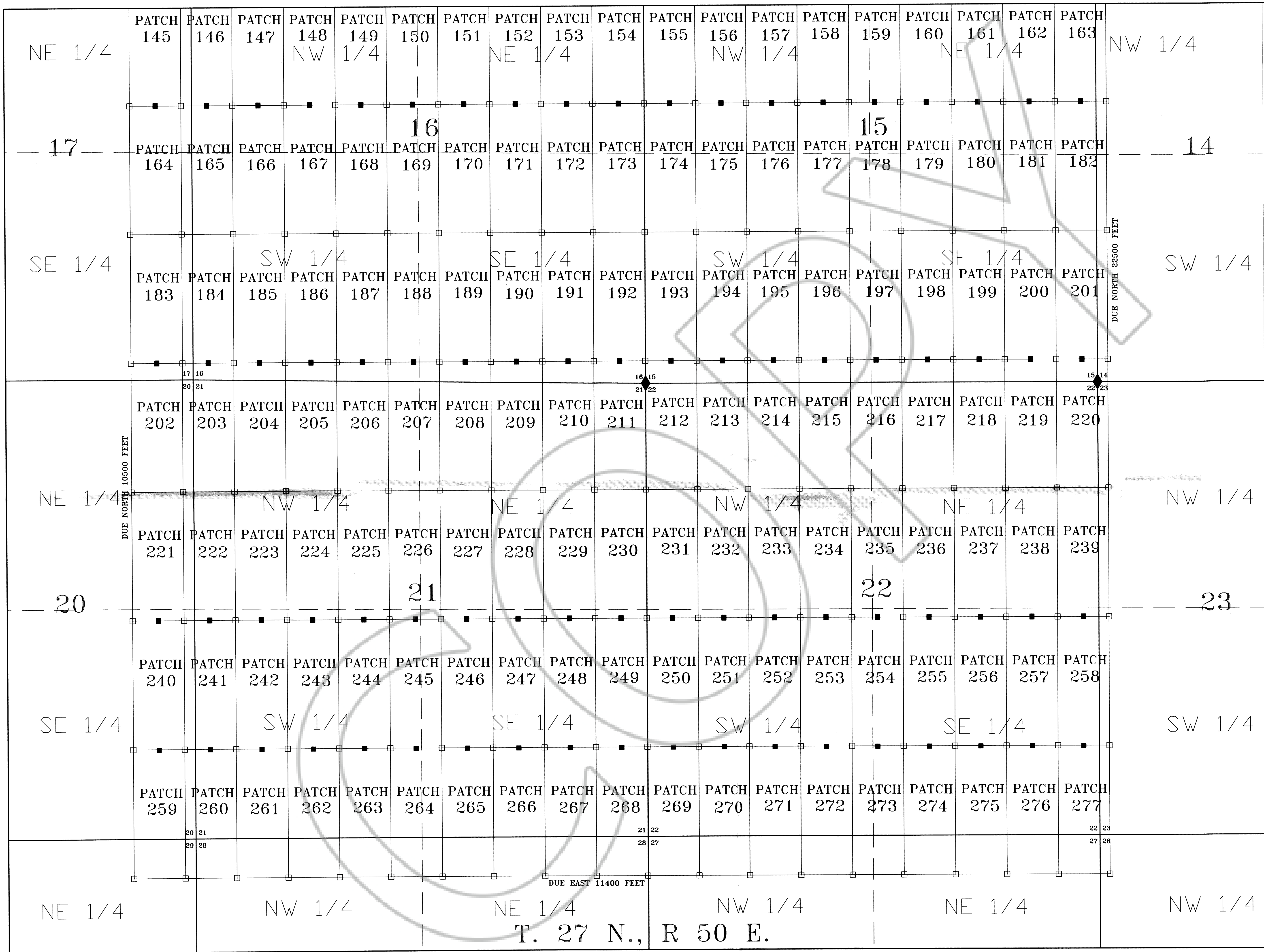

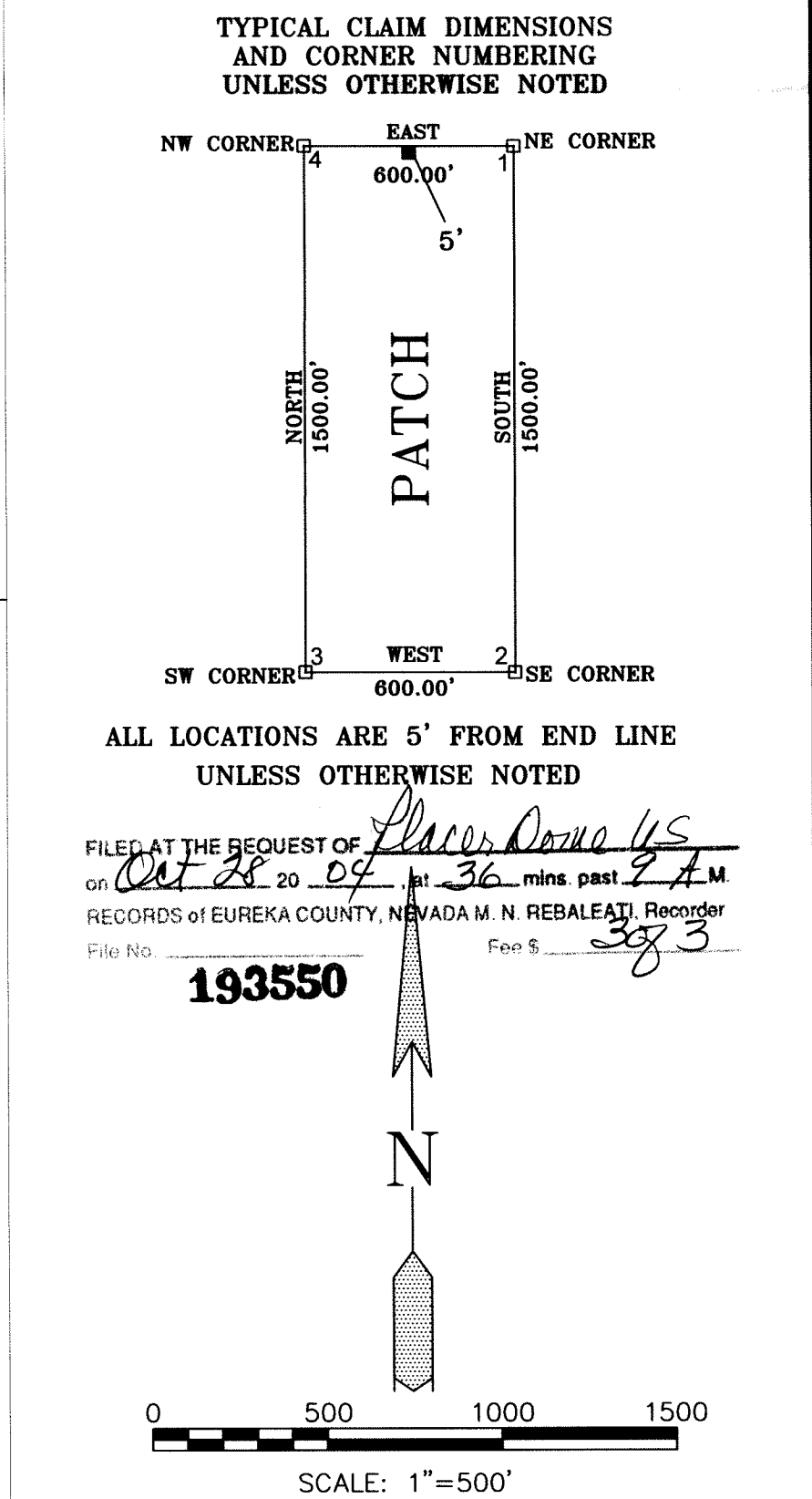
