CERTIFICATE OF LOCATION

The undersigned certifies as follows:

1. The name and mailing address of the locator is Toquima Minerals US Inc., 1 East Liberty St., Suite 424, Reno, Nevada 89501.

2. That on the 1st day of September, 2004, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the locator located and claimed the lode mining claim called the Flynn-103 mining claim (the "Claim").

3. The claim is located in the following quarter sections:

NE¼ of Section 16, Township 26 North, Range 52 East  
¼ of Section , Township 26 North, Range 52 East

4. The locator claims **25** feet in a **north** direction and **1475** feet in a **south** direction from the monument of location at which the Notice of location is posted, together with 300 feet in width on each side of the center of the vein or lode. The general course of the lode or vein, as near as may be determined, is **north and south**.

5. The position of each corner of the Claim is shown on the mining claim map recorded with this Certificate. The number, position and markings on each corner monument are as follows:

The location work consisted of making and recording of duplicate claim maps as provided in NRS 517.040 and incorporated by reference in this Certificate.
