**CERTIFICATE OF LOCATION

The Claim is approximately 1500 feet long and approximately 600 feet wide, such that 10 feet is claimed in a NORTH direction and 1490 feet is claimed in a SOUTH direction from the point of discovery (monument of location), at which the Notice of Location is posted, together with 300 feet on each side of the monument of location and centerline of the claim. The general course of the vein and these premises is NORTH / SOUTH.
