claimed in a S60E direction and 10 feet in a N60W direction from the point of discovery (monument of  
location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of  
location and center line of the Claim. The general course of the lode or vein is from the north to the south  
direction.

As erected on the ground, each corner monument is marked as described above by metal tags (e.g. metal tags, paint  
on posts).

The monumentation and markings of the above mentioned corners on the ground were completed on  
November 5, 2004, and the location work consisted of making a claim map as provided in NRS 517.040.  
Two copies of this map have been filed with the Eureka County Recorder, and the lode claim filing fee has  
been paid to the County Recorder.
