The Claim is approximately 1412 feet long and approximately 502 feet wide, such that 30 feet is claimed in a North 16°33'09" East direction and 1382 feet is claimed in the opposite direction from the point of discovery (monument of location), at which the Notice of Location is posted, together with 251 feet on each side of the monument of location and centerline of the claim. The general course of the vein and these premises is northeast and southwest.
