AMENDED
ORDER APPROVING
FIRST AND FINAL ACCOUNT,
PETITION FOR DISTRIBUTION,
TO FIX ATTORNEY'S FEES, AND
FOR DISCHARGE

The verified First and Final Account, Petition for Distribution, to Fix Attorney's Fees, and For Discharge of CARLTON S. THOMAS, Executor coming on regularly for hearing this 32nd day of December 2004, and due proof having been made to the satisfaction of this Court, and the Court so finding that the Clerk has given notice in all respects according to law, and GARY D. FAIRMAN, ESQ., a Professional Corporation, Counsel for said Executrix of said Estate, being personally present in Court, and no objections having been filed to said First and Final Account, Petition for Distribution, to Fix Attorney's Fees and For Discharge;

THE COURT NOW FINDS that ROY WILLIAM HILL, died testate on the 9th day of December, 2003, in the County of Lincoln, State

1 of Nevada, and at the time of his death was a resident of White
2 Pine County, State of Nevada; that CARLTON S. THOMAS, was
3 appointed by the above-entitled Court as Executor of the Estate
4 of said Decedent on the 19th day of April, 2004; that thereafter,
5 on the 19th day of April, 2004, said Executor qualified and
6 Letters of Summary Administration were issued to him, which
7 Letters have never been revoked, and the said CARLTON S. THOMAS
8 ever since has been and still is now the duly appointed,
9 qualified and acting Executor of the Estate of ROY WILLIAM HILL,
10 Deceased.

11 THE COURT FURTHER FINDS:

12 That Notice to Creditors was published in The Lincoln
13 County Record, a newspaper published in Pioche, Lincoln County,
14 Nevada, for the time and in the manner required by statute, due
15 proof of publication being on file herein and no claims were
16 filed against the estate.

17 That due to the nature and value of said Estate, the
18 Executor filed a Verified Record of Value with this Court,
19 showing the gross value of said Estate to be THIRTY THOUSAND NINE
20 HUNDRED FIFTY-NINE AND 46/100 DOLLARS (\$30,959.46).

21 That on the 31st day of August, 2004, an Order
22 Approving Petition for Partial Distribution was filed with the
23 Court whereby the motor vehicles were distributed to CARLTON S.
24 THOMAS and GWEMDOLYN M. THOMAS, sole heirs of the motor vehicles.

25 That due to the value of said Estate, it is not
26 necessary for said Executor to file a Federal Estate and

1 fiduciary tax returns for the year 2004.

2 That the names, relationships, and residences of the
3 heirs and devisees and the ages of any minor child(ren) of said
4 Decedent are as follows:

11 That the Executor, CARLTON S. THOMAS, has performed all
12 duties and services required of him as Executor of said Estate
13 and is entitled to compensation but has declined to accept the
14 same; that GARY D. FAIRMAN, ESQ., a Professional Corporation, has
15 rendered legal services to the Executor and to the Estate and is
16 entitled to compensation therefor and that said Attorney has
17 agreed with the Executor that a fee in the sum of TWO THOUSAND
18 DOLLARS (\$2,000.00) is reasonable and proper subject the approval
19 by the above-entitled Court; that said Attorney has advanced the
20 sum of FOUR HUNDRED ELEVEN AND 54/100 DOLLARS (\$411.54) as costs
21 and expenses in connection with his representation of the
22 Executor of the Estate which he has not been reimbursed.

23 That the Estate is now in a condition to be settled and
24 distributed pursuant to said First and Final Account, Petition
25 for Distribution, to Fix Attorney's Fees and For Discharge;

26 From the foregoing, the Court makes its Order as follows:

IT IS HEREBY ORDERED that said First and Final Account be, and the same is hereby allowed, approved and settled, and found correct in all respects;

IT IS HEREBY FURTHER ORDERED that after the payment of the fees herein, that the residue of said Estate be distributed pursuant to the Last Will and Testament of ROY WILLIAM HILL, to CARLTON S. THOMAS and GWEN THOMAS, husband and wife, to-wit:

4 advanced the sum of FOUR HUNDRED ELEVEN AND 54/100 DOLLARS
5 (\$411.54) as costs and expenses in connection with his
6 representation of the Executor of the Estate which he has not
7 been reimbursed.

8 IT IS HEREBY FURTHER ORDERED that at such time as said
9 Executor has made all proper transactions in accordance with this
10 Order, and has paid all expenses pursuant to this Order, that
11 Petitioner be discharged from his trust.
