personal liability of any person for payment of the indebtedness secured by said Deed of Trust.

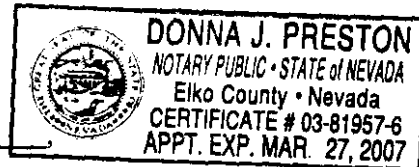
