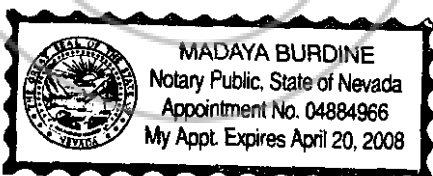
The undersigned, first being duly sworn, deposes and says:

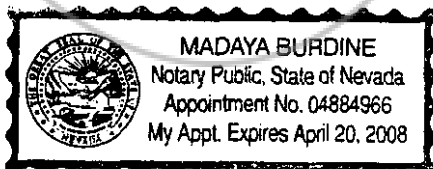
