## MEMORANDUM OF WATER RIGHT LEASE

THIS MEMORANDUM OF WATER RIGHT LEASE dated as of January 10, 2005, ("Effective Date") between JAMES P. and MONIQUE ITHURRALDE, HUSBAND and WIFE, and ROBERT J. and PATRICIA ITHURRALDE, HUSBAND and WIFE, ("Lessors") and HOMESTAKE MINING COMPANY OF CALIFORNIA, a California corporation whose mailing address is P.O. Box 676, Eureka, Nevada 89316 ("Lessee") shall provide notice that the parties shown above have entered into a Water Right Lease as of the Effective Date. The pertinent terms of the Water Right Lease are:

- 1. <u>Lease and Term.</u> (a) Lessors are the owners of Permit No. 18909 (Certificate No. 6560), Permit No. 24827 (Certificate No. 7944), Permit No. 64207 and Permit No. 64439 (the "Water Rights") for irrigation of land located in the same groundwater basin as the Ruby Hill Mine.
- (b) Lessors are willing to lease the Water Rights to Lessee, and Lessee is willing to lease the Water Rights from Lessors pursuant to the terms and conditions of the Water Rights Lease as summarized herein.


