Within 60 days after posting said notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4x4" or 2x2" wooden posts or native timber.

On each monument is a metal tag marked with the name of the claim and a diagram or statement indicating it's location. Location work consisted of making the map in accordance with NRS 517.040, which is recorded herewith.
