GRANT BARGAIN AND SALE DEED

THIS INDENTURE made as of the 20th day of October, 2005, by and between THE BOARD OF COUNTY COMMISSIONERS, acting as the Town Board for the unincorporated town of Eureka, Nevada, party of the First Part, and DAVID EDGAR GROTH AND SARA L. GROTH, husband and wife, as joint tenants with right of survivorship, party of the Second Part.

WITNESSETH

That First Party, the Grantor, for and in consideration of exchange of land of equal value, to it in hand provided by the Second Party, the Grantee, do hereby grant, bargain and sell to said Grantee, their heirs, successors, and assigns forever, all that certain lot, piece or parcel of land situate, lying and being in the Town of Eureka, County of Eureka, State of Nevada, which property was formerly a portion of Nob Hill Avenue before that portion was abandoned, and more particularly described on "Exhibit A", attached hereto.

SUBJECT TO and expressly reserving a ten foot easement for all existing utilities.

TOGETHER with all and singular tenements, hereditaments, and appurtenances thereunto belonging or in any wise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the said premises, together with the appurtenances, unto said Second Party, and to their heirs and assigns, forever.

THENCE along the westerly line of said Area B, N.08°57'31"W, 45.58 feet to the northwesterly corner of said Area B;

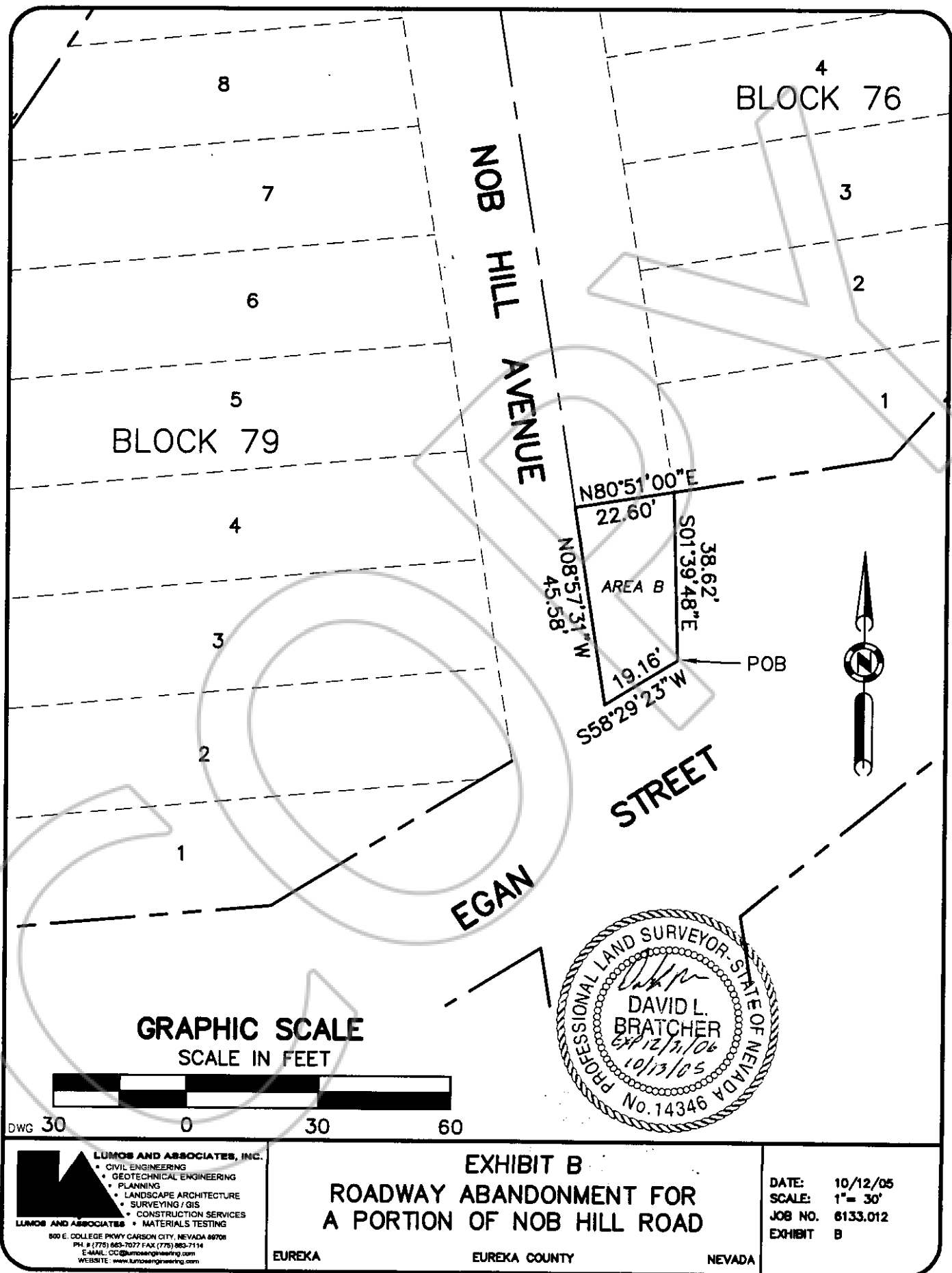
THENCE along the northerly line of said Area B, N.80°51'00"E., 22.60 feet to the northeasterly corner of said Area B;
