## First Amendment of Exploration and Option to **Enter Joint Venture Agreement Trend Project**

This First Amendment of Exploration and Option to Enter Joint Venture Agreement Trend Project ("First Amendment") is made by and between NDT Ventures (USA) Inc., a Nevada corporation ("Owner"), and Agnico-Eagle (USA) Ltd., formerly known as Nevada Contact Inc., a Colorado corporation ("Agnico").

## Recitals

- Owner and Agnico entered the Exploration and Option to Enter Joint Venture Agreement Trend Project dated effective October 1, 2004 (the "Exploration Agreement").
