CERTIFICATE OF LOCATION
Lode Mining Claim

NOTICE IS HEREBY GIVEN that Carl Pescio,
P.O. Box 5831, Elko, Nevada 89802, hereby claims under and
pursuant to the laws of the State of Nevada and of the laws of the United
States of America the following described LODE MINING CLAIM:

The name of the claim is the NM 38.
This claim was located on September 28, 2005, by posting a Location Notice at the discovery
monument found at, on, or near the South end of the claim.

The length of the claim is 1395 feet in a N 9° W direction and 5 feet in the opposite
direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the
center of the vein or lode, comprising in all 1400 feet in length and 600 feet in width, and generally
following a N 9° W to S 9° E course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument
consists of a 2" x 2" x 4 wooden post with aluminum tags attached, scribed with claim name and corner description,
set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the
Northwest corner:

thence 600 feet East to the NE corner, corner No. 2,
thence 1400 feet S 9° E to the SE corner, corner No. 3,
thence 600 feet West to the SW corner, corner No. 4,
thence 1400 feet N 9° W to the NW corner, corner No. 1, the point of beginning.
