**CERTIFICATE OF LOCATION**

NOTICE IS HEREBY GIVEN that **Carl Pescio**,  
**P.O. Box 5831, Elko, Nevada 89802**, hereby claims under and  
pursuant to the laws of the State of Nevada and of the laws of the United  
States of America the following described **LODE MINING CLAIM**:

The name of the claim is the BK 221.

This claim was located on September 12, 2005, by posting a Location Notice at the discovery  
monument found at, on, or near the West end of the claim.

The length of the claim is 1495 feet in a East direction and 5 feet in the opposite  
direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of  
the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally  
following a West to East course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument  
consists of a 2" x 2" x 4 wooden post with aluminum tags attached, scribed with claim name and corner description,  
set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the  
Northwest corner:

thence 1500 feet East to the NE corner, corner No. 2,  
thence 600 feet South to the SE corner, corner No. 3,  
thence 1500 feet West to the SW corner, corner No. 4,  
thence 600 feet North to the NW corner, corner No. 1, the point of beginning.
