CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that **Carl Pescio**,
P.O. Box 5831, Elko, Nevada 89802, hereby claims under and
pursuant to the laws of the State of Nevada and of the laws of the United
States of America the following described **LODE MINING CLAIM**:

The name of the claim is the **MH 127**

This claim was located on **September 20, 2005**, by posting a Location Notice at the discovery
monument found at, on, or near the **West** end of the claim.

The length of the claim is **1495** feet in a **East** direction and **5** feet in the opposite
direction from the monument where the Location Notice is posted, and the width is **300** feet on each side of
the center of the vein or lode, comprising in all **1500** feet in length and **600** feet in width, and generally
following a **West to East** course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument
consists of a 2" x 2" x 4 wooden post with aluminum tags attached, scribed with claim name and corner description,
set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the
Northwest corner:

thence **1500** feet **East** to the **NE** corner, corner No. 2,
thence **600** feet **South** to the **SE** corner, corner No. 3,
thence **1500** feet **West** to the **SW** corner, corner No. 4,
thence **600** feet **North** to the **NW** corner, corner No. 1, the point of beginning.
