### AFFIDAVIT OF TRUSTEE

The undersigned William A. Curtis, Jr., being first duly sworn, deposes and says that:

1. I am the duly appointed and acting sole Trustee of the Curtis Family Trust of 2000, Under Declaration of Trust dated December 8, 2000, as amended (the "Trust").

2. Certain real property interests in the Cortez Gold Mine in Lander and Eureka Counties, Nevada ("**Cortez**") were conveyed to the Trust pursuant to the following assignments, executed originals of which are attached hereto as Appendix A and incorporated herein by this reference (collectively the "**2000 Assignments**"):

a. ASSIGNMENT dated December 8, 2000 from JoAnn Wreisner Curtis, Trustee of the JoAnn Wreisner Curtis 1988 Trust, as Amended December 11, 1996, to JoAnn Wreisner Curtis, a married woman as her separate property;

b. ASSIGNMENT FROM JOANN WREISNER CURTIS 1998 TRUST, AS AMENDED, dated December 8, 2000 from JoAnn Wreisner Curtis, Trustee of the JoAnn Wreisner Curtis 1988 Trust, as Amended by First Amendment dated December 11, 1996 and by Second Amendment dated August 7, 2000, to JoAnn Wreisner Curtis, a married woman as her separate property;

c. ASSIGNMENT dated December 8, 2000 from JoAnn Wreisner Curtis to JoAnn Wreisner Curtis and William A. Curtis, Jr., Trustees of the Curtis Family Trust of 2000, Under Declaration of Trust dated December 8, 2000; and

d. ASSIGNMENT OF SEPARATE PROPERTY OF JOANN WREISNER CURTIS TO THE CURTIS FAMILY TRUST OF 2000 DATED December 8, 2000 from JoAnn Wreisner Curtis to JoAnn Wreisner Curtis and William A. Curtis, Jr., Trustees of the Curtis Family Trust of 2000, Under Declaration of Trust dated December 8, 2000.

3. The 2000 Assignments describe the interest in Cortez as all of the assignor's right, title and interest in and under that certain Assignment dated January 2, 1981 by and between Idaho Mining Corporation, a Nevada Corporation, and JoAnn K. Wilson,

individually, and as Executrix and sole devisee and legatee under the Will of A. K. Wilson, Jr. Deceased, W. L. Wilson, Joan Wilson and William G. Waldeck, which Assignment is recorded in Book 195 at page 30 of the Lander County, Nevada records and in Book 90 at page 223 of the Eureka County, Nevada records (the "1981 Assignment").

4. Documents of record in Eureka and Lander Counties, Nevada reflect that the interest acquired by JoAnn K. Wilson (subsequently known as JoAnn Wreisner Curtis and JoAnn W. Curtis) in the 1981 Assignment subsequently were exchanged with the owner and operator of Cortez pursuant to the following instruments:

a. Correction Special Warranty Deed and Bill of Sale dated August 9, 1993 (recorded in Book 400 at page 599 of the Lander County, Nevada records and in Book 254 at page 142 of the Eureka County, Nevada records), from JoAnn K. Wilson, individually and as Trustee of the JoAnn K. Wilson 1988 Trust, et al., conveying interests acquired in the 1981 Assignment and other interests to Cortez Joint Venture and Cortez Gold Mines; and

b. Correction Special Warranty Deed Conveying Overriding Royalty Interest dated August 9, 1993 by Placer Dome U.S. Inc., Cortez Joint Venture and Cortez Gold Mines, as Grantors, to W.L. Wilson, et al. (including JoAnn K. Wilson, as Trustee of the JoAnn K. Wilson 1988 Trust), as Grantees (recorded in Book 400 at Page 328 of the Lander County, Nevada records and in Book 253 at Page 405 of the Eureka County, Nevada records) (the "1993 Royalty Deed"), conveying an overriding royalty interest in all mining claims, mineral properties and interests owned leased or otherwise held by Grantors within the "Areas of Interest" in Lander and Eureka Counties, Nevada described in said deed.

5. As a result of the exchange described above, the interest in Cortez intended to be described in the 2000 Assignments necessarily was the interest acquired by JoAnn K. Wilson, Trustee of the JoAnn K. Wilson 1988 Trust, in the 1993 Royalty Deed.

6. By terms of an Order Confirming Trust Property and For Delivery (NRS 164.033) in the matter of the Trust Estate of: THE CURTIS FAMILY TRUST OF 2000, UNDER DECLARATION OF TRUST DATED DECEMBER 8, 2000, AS AMENDED, Case No. PR02-00914, in the Second Judicial District Court of the State of Nevada, In and For the County of Washoe, a certified copy of which is attached hereto as Appendix B and incorporated herein by this reference, the Court determined, *inter alia*, that the entire right, title and interest of JoAnn W. Curtis in the Cortez Gold Mine was established as Trust property subject to the terms of the Trust.

7. This Affidavit is being executed in duplicate originals for recording purposes. The executed original assignments described in paragraph 2 will be attached to the duplicate original of this Affidavit filed in the Eureka County, Nevada records, and copies of such assignments will be attached to the duplicate original of this Affidavit filed in the Lander County, Nevada records.

9 4. That the entire right, title and interest of JoAnn W. Curtis in Western Centennials,  
10 Inc., a Nevada corporation, is established as the jointly-held property of Timothy K. Wilson and  
11 Gregory A. Wilson; and

12 5. That the entire right, title and interest of JoAnn W. Curtis in Windfall Ventures is  
13 established as the jointly-held property of Timothy K. Wilson and Gregory A. Wilson; and

14 6. That Sinbad Mining Corporation, a Nevada corporation, had been liquidated and  
15 dissolved and, therefore, is no longer an asset of JoAnn W. Curtis; and

16 7. That Placer Dome, U.S., Inc., as a General Partner in the Cortez Joint Venture and  
17 the Cortez Gold Mine, is hereby dismissed from this action without prejudice in accordance with
