The Claim is approximately 1373.8 feet long and approximately 600 feet wide, such that 1348.8 feet is claimed in a North 1°36' East direction and 25 feet is claimed in the opposite direction from the point of discovery (monument of location), at which the Notice of Location is posted, together with 300 feet on each side of the monument of location and centerline of the claim. The general course of the vein and these premises is northeast and southwest.
