pursuant to the laws of the State of Nevada and of the laws of the United
States of America the following described LODE MINING CLAIM:

The name of the claim is the DRY 11
This claim was located on October 6, 2005, by posting a Location Notice at the discovery
monument found at, on, or near the South end of the claim.

The length of the claim is 1495 feet in a North direction and 5 feet in the opposite
direction from the monument where the Location Notice is posted, and the width is 200 feet on each side of
the center of the vein or lode, comprising in all 1500 feet in length and 400 feet in width, and generally
following a North-South course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument
consists of a 2" x 2" x 4 wooden post with aluminum tags attached, scribed with claim name and corner description,
set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the
